Online Records Access

There are currently two options available to access records on-line: Tapestry and Laredo.

TAPESTRY

Tapestry is an Internet access program designed for the occasional user. If you do not have a good real estate background, you will have no difficulty using Tapestry. From the Tapestry web site, users can access information from ALL participating counties.

No software download required- all you need is a web browser. Tapestry utilizes a pay-as-yougo method in which you can pay with your credit card on a secure internet site.

This option is an Internet based access program designed for more frequent users such as title companies and other real estate related firms that operate in Wisconsin and need access daily to the land records in the Lincoln County Register of Deeds office.

How is Access Obtained?

Wall Dates

The general rule is that the grantor/grantee (or party) index, tract index (by legal description) and image is available the next working day after being recorded. There are occasional exceptions due to equipment failures and high recording volumes. Effective date is the last indexed and verified date as shown on the bottom of the Laredo screen.

Note: The effective date may fluctuate with the volume of documents recorded.
